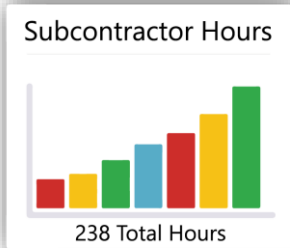
# myComply Spotlight: Bozzuto Construction



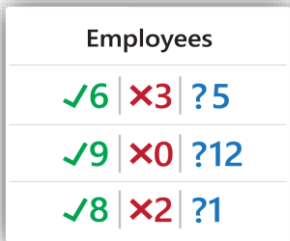
- Bozzuto has the ability to identify companies who have not submitted compliance documents on time during the onboarding process.

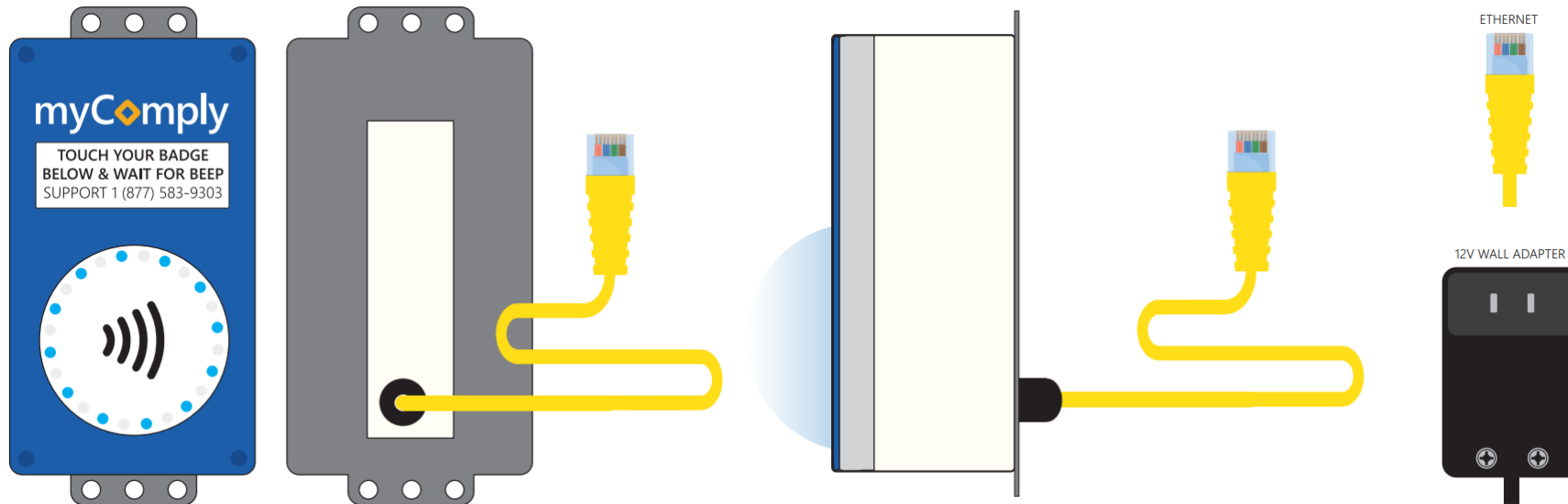

# COVID-19 Control

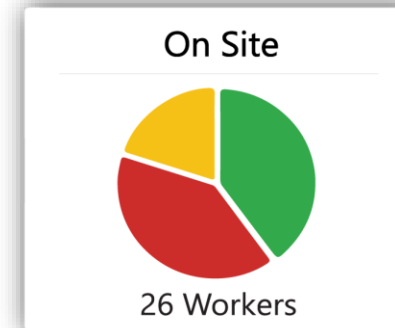

- Daily health screening surveys that are completed by workers on-site to ensure potential infected workers are not on-site (Mobile Survey – Right Image)
